STATEMENT ON PROCESSING OF PERSONAL DATA

Information pursuant to and for the purposes of Articles 13-14, EU Regulation 679/2016 (European Regulation on the protection of personal data)

Alimentari Pasqualetti Srl, with registered office in Strada Provinciale per San Gimignano, Località Le Lame, Poggibonsi (Siena, Italy), Tax and VAT number 01387390527 (hereinafter referred to as the "Data Controller" or "Controller"), as Data Controller, hereby informs you that the EU Regulation 679/2016 (European regulation on the protection of personal data) provides for the protection of individuals and other entities in regard to the processing of personal data. In accordance with Articles 13 and 14, we therefore provide you with the following information:

1. Purpose and legal basis of the data processing

The processing of personal data provided by you is intended solely to perform contractual obligations and to meet your specific requirements, as well as to comply with regulatory obligations, particularly concerning accounting and taxes. For the purposes of this processing, the Data Controller may become aware of data defined as "sensitive" under EU Regulation 679/2016, such as those disclosing racial or ethnic origin, religious, philosophical or other beliefs, political opinions, membership of parties, trade unions, associations or organizations of a religious, philosophical, political or trade union nature, health or sex life.

2. Methods of treatment

Your personal data are subject to computer and paper processing for the purposes indicated. The processing operations are carried out in such a way as to guarantee the logical and physical security and the confidentiality of the data.

3. Nature of personal data

The data processing will concern your personal, sensitive and legal data in regards to the service you request. During the provision of the service it may be necessary to acquire and carry out operations of processing of sensitive personal and legal data, in which case you will be asked to give your consent in writing.

4. Obligatory or optional nature of providing personal data

The provision of your personal and sensitive data is not obligatory, but any refusal could make it impossible or extremely difficult to provide the services you request.

5. Scope of communication and dissemination of data

Your data may be communicated to:

- all entities whose right of access to such data is recognized by virtue of regulatory measures;
- our collaborators and employees, within the scope of their duties;
- all those natural and/or legal, public and/or private entities for whom the communication of the data is necessary or functional to the performance of our activities, in the manner and for the purposes set out above.

6. Storage of personal data

The Data Controller will process personal data for the time necessary to fulfil the above purposes and in any case for no longer than 10 years from the termination of the relationship for the purposes of the service.

7. Identification details of the Data Controller, data manager and persons in charge.

The Data Controller is Alimentari Pasqualetti Srl, with registered office in Strada Provinciale per San Gimignano, Località Le Lame, Poggibonsi (Siena, Italy), e-mail: info@alimentaripasqualetti.it. The updated list of data managers and persons in charge of data processing is kept at the registered office of the Data Controller.

8. Rights of the data subject

8.1 Articles 15 (right of access), and 16 (right of rectification) of EU regulation 679/2016

The data subject has the right to obtain confirmation from the Data Controller as to whether or not personal data concerning them are being processed, and if so, to obtain access to the personal data and to the following information: (a) the purposes of the processing; (b) the categories of personal data concerned; (c) the recipients or categories of recipients to whom the personal data have been or will be disclosed, in particular where they are recipients from third countries or international organisations; (d) the intended retention period for the personal data or, if that is not possible, the criteria used to determine that period; (e) the existence of the right of the data subject to request that the Controller correct or erase the personal data or

restrict the processing of personal data concerning them, or to object to their processing; (f) the right to lodge a complaint with a supervisory authority; (h) the existence of an automated decision-making process, including profiling, and in such cases to obtain meaningful information on the logic used, and the importance and expected consequences of such processing for the data subject.

8.2 Article 17 of EU regulation 679/2016 (right to erasure or 'right to be forgotten')

The data subject has the right to obtain from the Controller the erasure of personal data relating to them without undue delay. The Controller has the obligation to erase the personal data without undue delay, if any of the following reasons exist: (a) the personal data are no longer necessary for the purposes for which they were collected or otherwise processed; (b) the data subject withdraws the consent on which the processing is based in accordance with Article 6(1)(a) or Article 9(2)(a) of EU regulation 679/2016 and if there is no other legal basis for the processing; (c) the data subject objects to the processing pursuant to Article 21(1) and there are no overriding legitimate grounds for the processing, or the data subject objects to the processing pursuant to Article 21(2); (d) the personal data have been processed unlawfully; (e) the personal data must be erased in order to comply with a legal obligation under European Union law or the law of the Member State to which the Controller is subject; (f) the personal data have been collected in relation to the provision of information company services as referred to in EU 679/2016.

8.3 Article 18 (right to limitation of processing)

The data subject has the right to obtain the limitation of processing from the Data Controller, when one of the following situations occurs: (a) the data subject contests the precision of the personal data, for the time necessary for the Data Controller to verify the precision of the data; (b) the processing is unlawful and the data subject objects to the deletion of the personal data and instead requests that their use be restricted; (d) the data subject has objected to the processing pursuant to Article 21(1) of EU regulation 679/2016, pending examination as to whether the legitimate reasons of the Data Controller take precedence over those of the data subject.

8.4 Article 20 of EU regulation 679/2016 (right to data portability)

The data subject has the right to receive the personal data concerning them and provided to the Data Controller in a structured format, commonly used and readable by automatic device, and has the right to transmit such data to another data controller, without hindrance from the current Data Controller.

9. Transfer of personal data to a third country

Personal data are stored on the server located at the registered office of the Data Controller, within the European Union. In any case, it is understood that the Controller if necessary, has the right to move the servers, including to outside the European Union. In this case, the Controller guarantees that the transfer of the personal data to any location outside the European Union will take place in accordance with the applicable legal provisions, and subject to the stipulation of the standard contractual clauses provided for by the European Commission.

10. Revocation of consent to the processing of personal data

You are entitled to revoke your consent to the processing of your personal data by sending a registered letter with return receipt to the following address: Alimentari Pasqualetti Srl, S.P. per San Gimignano, Loc. Once you have performed this operation your personal data will be removed from the archives as soon as possible.
